Any member excused from any seven (7) meetings will be called to a hearing before the Advisors and 2-4 senior members, who have parliamentary rights in the hearing, but no voting rights, and the state of their membership will be determined, along with any repercussions that entails. Any member with a combination of unexcused and excused meetings, totaling five (5) will be called to a hearing before the Advisors and 2-4 senior members, who have parliamentary rights in the hearing, but no voting rights, and the state of their membership will be determined, along with any repercussions that entails”.
